

Checklist for the thesis copy

This is a help guide, made through a checklist. It must not be incorporated into the doctoral thesis or your SVA.

Before the end of the deadline for the presentation (“Expected end date” in your academic record)

CONFIRM IN THE VIRTUAL SECRETARIAT (SVA) THAT:

You have the Supervision Agreement (CDS) signed	
You fulfill the minimum time period for thesis submission	
You have passed all complementary training	
All your training activities were assessed	
You have reviewed all your annual assessments	
You are not in a temporary leave	
You registered, with no pending payments, to make the defense application	
You have not requested a previous defense. If so, you need to contact EDIUS	
<p>You have updated and approved your research and training plan (RTP). If not, when you submit your application through your SVA you are able to request it.</p> <p>Please, verify:</p> <ul style="list-style-type: none"> • That the language of the doctoral thesis matches the RTP. • That the doctoral thesis title matches the one approved in the RTP. • That you have a single research line assigned to the subject of your doctoral thesis. 	

FURTHERMORE, THE FOLLOWING ITEMS MUST BE CHECKED:

The structure of all doctoral theses includes a summary. If the language is different from Spanish or Galician, that summary will be written in Galician with a word count of, at least, 3.000 words.		
You have the corresponding permissions for figures and graphics that are not your own work and appear in the thesis. You will have to include them in an appendix in the doctoral thesis.

Thesis with total or partial reproduction of one or more publications

The thesis must include only and exclusively the list of publications that provide content for it, in line with the RTP.

Thesis by compendium of publications

(*) Publication requirements:

- That they have definitive acceptance or are published in publications of international scope and prestige with anonymous peer review.
- That they are indexed in journals of recognized impact in the corresponding scientific field. In particular, those included in the Journal Citation Reports (JCR) or Scopus. In areas where this criterion is not applicable, it may be substituted by databases related to these areas.
- At least one of the publications must be in the first or second quartile of its category. In the broad areas of Arts and Humanities and Social and Legal Sciences, contributions may be books or book chapters with a quality seal in academic publishing or that are included, for example, in Scholarly Publishers Indicators in Humanities and Social Sciences.
- The doctoral candidate's contribution to the publications included in the compendium must be substantial. The publications must align with the thesis project outlined in the research and training plan, and the publications must clearly reflect the doctoral candidate's affiliation with the USC.
- None of the articles included in the thesis may be prior to the date of enrollment in the doctoral program during the academic supervision period.
- The doctoral candidate's affiliation in the publication must include the USC.

Specific criteria

Statistical adequacy list in case none of the other three specific checklists were covered.

For theses that involve human subjects, human samples, or personal data

- Declaration of approval by the Research Bioethics Committee and study registration code
- Copy of the favorable report
- When appropriate, a declaration that the data is based on anonymous information and therefore no approval from the research ethics committee is required
- If the study is observational, STROBE checklist
